1. ANNOUNCEMENT:

The Gawler Motorcycle Club, hereafter called the PROMOTER will conduct a Closed to Club Enduro series for Solo Motorcycles. RND 1, Sunday 21st May at Marrabel Rnd 2, Sunday 6th August at Robertstown, Sunday 10th September at Marrabel

2. JURISDICTION:

The abovementioned meeting has been authorised by Motorcycling SA Inc which has issued the Motorcycling Australia Permit Number C17077, C17078 & C17079 and is open to holders of current Motorcycling Australia Junior Club, Junior National, Senior Club, Senior National or a one event licence purchased on the day.

2.2. The meeting will be held in accordance with the current General Competition Rules (GCR's), these Supplementary Regulations, and any final instructions approved by Motorcycling SA Inc. BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.

3. ENTRIES:

- 3.1. Postal entries open forthwith and need to be received by **Sunday** prior to each round. Online Entries open five weeks prior to each round and close **midnight Sunday** Prior to each round. (Online entries are our preferred method)
- 3.2. In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by Gawler Motorcycle Club, if such retention is approved by Motorcycling SA Inc.
- 3.3. Only entries received on the official entry form that is accompanied by the correct fee or via our on line entry system (available at www.gawlermcc.com.au) will be accepted.
- 3.4. <u>NOTE:</u> LATE ENTRIES WILL NOT BE ACCEPTED AND THE RETURN OF ENTRY FEES FOR ANY RIDER WITHDRAWING FROM THE MEETING IS AT THE DISCRETION OF THE GAWLER MOTORCYCLE CLUB.

4. INSURANCE:

- 4.1. National Personal Accident Scheme provides basic cover for death and permanent disability.
- 4.2. Ambulance Insurance is compulsory for licensees.
- 4.3 IT IS STRONGLY RECOMMENDED THAT COMPETITORS GIVE CONSIDERATION TO TAKING OUT WEEKLY BENEFITS INSURANCE.

5. MEDICAL SERVICES:

First Care medical will be in attendance.

6. ENTRY FEE:

- Senior \$50 / Junior \$35, Per Rider. One Event Licences \$90 plus entry fee Junior Non-Competitive \$30. One Event Rec Licence \$30 plus entry.
- Payment by cheque or money order only if posting entry, via our online entry system or with EFTPOS at Club Meetings. ANY FEES FOR DISHONOURED CHEQUES WILL BE THE RESPONSIBILITY OF THE ENTRANT.
- o Cheques and money orders are to be made payable to the Gawler Motorcycle Club Inc.

7 CLASSES OF COMPETITION:

Seniors:

- o Experts
- Clubman (4 Stroke)
- Clubman (2 Stroke)
- Veterans (35 44 years of age)
- Masters (45 years of age and over)
- Pony Express**

Juniors:

- o Junior A: (riders both between 8 -11 as of the 1st January) (65cc 2 stroke) & (85cc 2stroke/150cc 4 stroke)
- Junior A Pony Express.**
- Junior B (riders both between 12 -16 as of the 1st January) (100cc 125cc 2 Stroke) & (128-150cc 2stroke/200 250cc 4 Stroke)
- Junior B Pony Express. **

• Junior Non-Competitive*

*Junior non-competitive class is available to reduce the cost of Juniors trying out for the sport. Riding groups will be determined on the day of each event. No trophies, or results will be issued for this class. A rec licence will be required for the cost of \$30.

** Pony Express Teams will consist of rider pairings. The teams shall complete the marked course by riding for a given time, completing laps alternatively (eg: one lap per rider, per pairing) until the time nominated by the Gawler Motorcycle Club is complete. Rider pairings can consist of 2 senior riders, 2 Junior A riders, 2 Junior B riders. If a rider at some point in their career of motorcycling has been deemed Expert (in any discipline), they may not ride with another Expert.

8 AWARDS AND PRIZEMONEY:

Awards will be given out to the top 3 positions in each class. Presentations will occur at the following round, and series awards will be presented at our club end of year function. Results and series points will be made available at www.Gawlermcc.com.au

9 ENTRIES TO CONSTITUTE A CLASS:

- o To constitute a class, the number of contestants entered and competing in each class shall be a minimum of 3.
- Should there be insufficient entries in any class of competition, the decision to run or cancel the class, or to combine events and redistribute any awards and / or prize money, will be at the discretion of the Gawler Motorcycle Club, subject to Motorcycling SA Inc. approval.

10 RACE FORMAT:

Round 1 - Sprint Format

Round 2 - Cross Country Format

Round 3 – Cross Country Format.

11 MACHINES AND RIDER NUMBERS:

- o All machines entered must comply with the current GCRs for Enduro competition.
- Series Riding Numbers need to be registered prior to entering. These can be registered at <u>www.Gawlermcc.com.au</u> by filling the request form. Whilst we will do everything we can to allocate you the number that is already on your bike (e.g. SAORC or MX Number) this may not always be possible and will be a first in best dressed arrangement.

12 RIDERS' BRIEFING:

A riders' briefing will be held prior to the commencement of racing, which ALL competitors MUST attend. Riders will be required to sign to say they have attended riders briefing. Details will be included in the final instructions.

13. DRUG AND OR ALCOHOL TESTING:

- All competitors and officials are advised that as part of the MA and MSA drug education program, drug testing may take place at any competition in accordance with Australian Sports Commission policy as implemented by the Australian Sports Drug Agency and the Motorcycling SA Drug and Alcohol Policy.
- If any doubts exist over banned substances it is recommended competitors contact the Drugs in Sport Hotline, tel 1800 020 506.
 When drug testing takes place, the payment of prizemoney may be delayed at the Motorcycling SA Inc. discretion until the results of the tests are known.

14. CODE OF CONDUCT:

All competitors, officials and parents are reminded of the Motorcycling Australia by-law - CODE OF CONDUCT (as stipulated in the GCRs), which is a guide to appropriate behaviour at all motorcycle race meetings. This CODE OF CONDUCT applies to this Meeting and will be enforced.

15 TIMETABLE: (Please refer to the riders notes for the time table revised for that event)

Junior - Competitive

- 9:30-10:30am Junior's A Race
- > 10:30-12:00- Junior B Race
- > 12:00 Presentation from previous rounds

Seniors

- > 9:00-12:00 Senior's machine examination and rider sign on
- > 12:00- Presentations from previous rounds.
- > 12:30-1:00 Senior's rider's briefing and sight lap
- 1:00-4:00pm Senior's Race

The above times are a guideline only and are subject to change at any time.

For the purposes of drug and alcohol testing, the commencement of the meeting will be deemed to be 8:30am with the completion of the meeting for the participant being when the participant has vacated the venue.

- 16 CIRCUIT DESCRIPTION: As the course, will vary for each venue, a course description will be included in the final rider's notes.

 A typical course will be consisting of natural terrain including rocks, sand, dirt & scrub.
 - The course will be marked with, arrows and bunting. Anyone found to be not sticking to the marked course, maybe asked to leave, and take no part in future Gawler Motorcycle Club events.

17 STARTS:

Riders will leave in their respective classes as determined by the Gawler Motorcycle Club on the day of the event.

18 RACING:

SPRINT: A sprint consist of a special test(s). Riders complete as many heats of the course as the time schedule allows (issued with the final riders notes) or as directed by the Clerk of Course.

Times will be indicated in seconds, and added up across the day. The rider with the smallest total time for each class will be the winner and so on.

- Starting order will be in your riding number order on the first lap, riders may be reseeded during the day at the discretion of the clerk of course.
- To be a finisher a rider must start all heats and complete at least 75 percent of the heats. A rider who does not complete a heat will be awarded the slowest heat time in their class plus 100 seconds.
- o Receiving outside assistance is allowed in the defined pit area during the event.

CROSS COUNTRY: Cross Country events will be conducted on a course length of 15-30 minutes. (or as indicated in the final riders notes)

- Refuelling & Pit Area: A designated refuelling area will be available and all refuelling and mechanical work will be carried out only in this area. There is to be no camping in the pit area and Riders must refuel at least once during the event.
- Receiving outside assistance is allowed in the designated pit area throughout the course of the event. Engines must be stopped and the rider must be off the bike for refuelling. Penalty is exclusion.
- Juniors will compete at different times to the senior classes. The race will start at the time designated by the clerk of course, classes will start normally at one minute intervals and finish in the same order.
- o Riders completing less than 50% of the time/distance of the winner of the race will be classified as 'Did Not Finish' (DNF)
- The riders machines must not have left the marked course including the refuelling area during the race except in the case of injury or mechanical breakdown.
- For the Pony express class, riders must "high five or tap tyres" during change over.
- If a rider has either run out of fuel or has a mechanical problem they can only continue by pushing the machine back to the pit area (with no outside assistance). Upon restarting a penalty of one full lap will be applied unless the current lap was completed in full via pushing. Junior riders are required to complete one lap to be declared a finisher.

Race Duration

- Junior Non-Competitive will be riding for 1hr.
- Junior A will be racing for 1hr plus 1 lap.
- Junior B will be racing for 1.5hrs plus 1 lap.
- Seniors will be racing for 3hrs plus one lap.

Race times are a guide only and are subject to change at the clerk of courses discretion

Important Information for Junior Riders:

- A rider's age on 1 January will determine his/her age for competition that year. However, a rider may move to the next higher class when he/she becomes eligible to do so during the year, but once a rider moves to the higher age class in any competition, he/she may not go back to the lower age class. Points earned in a lower age class will not transfer to the higher class. This rule will apply to all riders up to and including 16 years old.
- If you start in an age group at the beginning of the series and if you move up into the next age group during the year, you cannot drop back and finish the series.
- Logbooks All junior riders **MUST** hand their Log Book in at Sign On.

19. NOISE:

Noise emissions as per the 2017 MoMS – Chapter 14.15.

20. GST:

The Goods and Services Tax affects the payment of prizemoney. If you do not provide an ABN or declare the sport is a hobby, the Promoter must withhold 48.5% of prizemoney over \$50.00 which is otherwise payable to you. Please tick one of the boxes on the entry form and if appropriate provide your ABN to ensure the full amount of prize money is paid to you.

21. Results:

- Results may be displayed across the duration of the event, these are to be taken as in progress and will not include any time adjustments, and or penalties issued by the clerk of course or Steward.
- o Provisional results will be released on the club's website (<u>www.Gawlermcc.com.au</u>), these will include any required changes.
- Results will be published as final 7 days after the event. No further changes will be made.
- Explanation of results A competitor may, no more than 7days after the publication of the results request from the Clerk of Course an explanation of those results. All requests must be submitted in writing to <u>events@gawlermcc.com.au</u>.

SPECIAL NOTES AND WARNINGS:

- o No tear offs are allowed in Enduro events.
- o All refuelling must be done with the motorcycle engine off.
- Environmental mats 1600mm long and at least 1000mm wide must be placed under all motorcycles whilst refuelling or changing oils. Carpet or any material not made for the absorption of petroleum products is not allowed to be used.
- Presentations will be held at the following round. Series awards will be presented at the club's end of year function.
- Catering will be available at each round.
- Toilet Facilities will be at each round.
- o Camping will be available at each round unless noted in the Final rider's instructions.
- o Track marking and preparation will occur the day before the event. Everyone is welcome and encouraged to attend.
- Final rider's instructions will be available at www.Gawlermcc.com.au, these will contain maps to the venue and important Information regarding the round.
